OLD BUSINESS:

The truck committee reported that they are meeting this Thursday night to work on truck the replacement truck for F-1220.

M.Corsiglia reported that the cascade compressor is still down, problem with compressor head. Head bolts are needed No repairs completed yet. They had to order parts.

D.Ricci reported that he and the Chief and M.Panco are working with the grant writer. We are sending him a 1/2 payment to get started.

M.Corsiglia reported that F1223,F1221 and F-1222 still need to be serviced this year @ Berco. F-1223's pump was serviced (but the packing still needs to be repaired). F-1221's pump and generator were serviced. Need to keep eye on air primer may be a problem.

M.Corsiglia reported that we are still waiting for the (200) N95 masks to come in.

Dave Ricci advised that he still was in the process of ordering the refrigerator.

D.Ricci reported that he purchased 3 cigarette butt collectors, they will be mounted on the outside walls in 3 locations.

B.Ruggeri reported that F-1223's new 800 mobile radio is ordered from Wireless Communications.

M.Corsiglia reported that the 3 new SCBA bottles are on order.

M.Corsiglia reported that 6 sets of turnout gear that are needed, have been ordered and members measured.

M.Panco advised that we are still waiting for a bill from Mid-Atlantic for grounds keeping.

B.Ruggeri is still looking into prices for fittings that are needed to be able to hook into farm pumps in the event of a large fire in our area.

D.Ricci advised that he has spoken with John Vastano and advised him that we want to keep the LOASP account separate from the regular checking account, John said no problem.

NEW BUSINESS:

M.Corsiglia reported that Crash Course Extrication classes in Ohio were offering 2 (4) day classes in September for certified technician training. He will see if any members are interested.

D.Ricci suggested that the Fire co should have official member ID cards. We have been unable to get any thru the county for almost 20 years. He spoke with DNS our security vendor for the building and they have cards that can also be programmed to be a fob for door entry. The Rescue squad as the laminating machine. is would cost us \$540.00 for 100 cards. Motion to purchase by M.Panco 2nd by D.Ricci

M.Panco mentioned the storage room is cleaned up by both us and the squad, much more organized.

D.Ricci mentioned that it would be nice if the light in the vestibule tower would be on at night. He will look into getting a timer at the wall switch that will work.

M.Corsiglia reported that he needs 3 new pagers @ \$325.00 ea. Motion to purchase by R.Ruggeri 2nd W.Corsiglia

M.Panco reported that he saw some leaks in the ceiling and wall in the 2nd floor TV room. He will keep an eye on it.
