D.Ricci had some quotes from a company RiTec on the exhaust fan repairs. \$512.00 each to replace all 4 existing fans (\$2,048.00) in the building. (RiTec) stated that these will be obsolete by the end of 2021. To replace all 4 with the latest equipment will be \$3,900 and then a \$1,600 yearly service fee. We will wait and discuss further options.

M.Corsiglia reported that the (6) 800 portable radios are ordered and the (2) mobile radios and (1) Bluetooth mic are also ordered. Birch's Communications will install the Mobile radios in both F-1222 and F-1227.

M.Panco reported that the drain in the ladies room was clogged again today. It is now repaired, Hopefully there will be no more issues.

M.Panco stated that he and J.Kline are working on getting copies for our records of training that some of the members have had at other training classes other than here.
