OLD BUSINESS:

M.Panco reported that we will waiting to receive the portable water softener donated to us by Quinlan well drilling.

The truck committee reported that they are going to start aggressively looking at some trucks and working with some vendors for F-1220's replacement.

M.Panco stated that we will get together on 2/24 to work on the equipment list further, that we still owe D'Augustino Ins.

M.Panco reported that the 3 storage cabinets are now installed and the contents have been gone through and organized.

M.Corsiglia reported that F-1227's rear bumper has not been delivered yet.

M.Corsiglia reported that the 800 mobile radio is installed in F-1221 but still needs to be programmed.

M.Panco reported that the hot water issue was checked out in the building. Many valves were clogged with sediment, they are repaired. The plumber is recommending that we install a timer in the DCon room to only allow very hot water to be used only when needed. M.Panco will check into this.

M.Corsiglia reported that the cascade compressor is still down, no repairs yet.

M.Panco reported that he repaired the s/west corner exit light and we will wait on the possibility of changing the bay lights over to LED, maybe sometime in the future.
