A decision was made to start working on the replacement of pumper F1223 which is now 30 years old. All members present agreed that this tuck replacement makes the most sense. The truck committee will start on the project, which it will probably take a couple of years to complete.

D.Ricci reported that the grant writer has submitted our grant request. D.Ricci also reported that our SAM'S # will be expiring in Sept. He will work on getting it renewed.

B.Ruggeri is still looking into prices for fittings that are needed to be able to hook into farm pumps in the event of a large fire in our area.

D.Ricci reported that we are working on getting the official member ID cards made very soon, they will be meeting with D&S about it tomorrow.

M.Panco reported that he was working with M.Corsiglia on a list of how many turnout gear and boots that we will be needing. Pricing is from MES \$1,509 for coat, \$990 for pants, \$380 for boots. Another quote of \$320.00 from Mid Atlantic for boots

M.Corsiglia advised that the helmet plaques are in.

M.Corsiglia reported that the new tree chainsaw is now in.

M.Corsiglia reported that the new pagers are not in yet.

M.Panco reported the some of the gutters are leaking, he will reseal them soon.

D.Ricci stated that he is working a company called Ritec on the exhaust fan problems in the ambulance bays.

D.Ricci reported that some of the vestibule windows are now sealed by South Jersey Glass.

Discussion from earlier this year was held again on purchasing 6 more 800 portable radios for \$10,500.00 and 2 mobile radios for \$5,400.00 and Bluetooth mic for \$335.00. Motion by M.Panco to purchase them 2nd by L.Ricci.

NEW BUSINESS:

M.Panco reported that the drain in the ladies room was clogged again, he is handling the repair with our plumber. Cost will be around \$375.00.

M.Panco stated that we were are having some problems with some members in getting copies for our records of training that they have had at other training classes other than here. He will work with J.Kline our training officer in tracking down these certificates.

M.Corsiglia requested to get some lights replaced on F-1222 with LED lights. There are some lights that are not LED. It would help the electrical system last longer, now that the tuck is 20 years old. He will get a quote.

D.Ricci reported that he received an e-mail from the township stating that Statewide ins (JIF) and the twp were looking for our member roster and copies of the members fire certificates. He stated that this request was sent to all 5 fire companies in the twp. He will be working on getting what they need.

D.Ricci received a call from our grant writer about next year's grant and what we would like to try for. Maybe a new air bottle refill system since our was down for a year due to parts issues. We will discuss further. M.Corsiglia will also call BMA Compressor Co (a new company) to get a quote from them for service on our current system.
