M.Corsiglia advised that the GMI gas meter has been repaired.

D.Ricci advised that he had spoken with the exterminator and advised him that we were done with him. He advised that he had spoken with IPM pest control that the township uses. The yearly cost is \$400.00, they will service us monthly and report what they do each month. Motion to hire them by M.Panco 2ns L.Ricci

M.Corsiglia reported that the new tree chainsaw is not in yet.

M.Panco found the proper paint color for the door going into the dayroom, W.Corsiglia will repaint it. He still needs to check out the flaking paint in the dayroom.

M.Corsiglia reported that the new pagers are ordered.

NEW BUSINESS:

M.Panco reported the some of the gutters are leaking, he will reseal them.

The renewal for Tango/Tango is due for the year. M.Corsiglia stated that it is working and we should continue with it.

M.Corsiglia stated that the exhaust fans are going off in the ambulance bays. All the ambulances are now gasoline and the sensors are being set off by the fumes. We will call Capri construction to see if they have any information on this issue.

D.Ricci reported that some of the vestibule windows are leaking and the rug is wet. He called South Jersey Glass and had them come out. They advised that they need to be resealed. Cost will be \$895.00. Motion by W.Corsiglia to have the repairs made 2nd by D.Ricci.
