M.Panco and M.Corsiglia reported that we have found several leaks in the roof. Capri Construction came and checked it out. some rivets were loose which they tightened up, they ordered a special sealant and they will be back to make the final repairs.

M.Panco reported that he had purchased a lock out tag out kit.

M.Panco stated that the keys in the small key box need to be checked and moved into the new larger box.
