D.Ricci advised that he had attempted to call the exterminator, but has not received a call back. We will hold the check and see if that works.

M.Corsiglia reported that he is working on setting up the cpr class.

M.Panco reported on the price of the Rolling Rack battery powered unit to make it easier to roll up 100 ft lengths of 5" hose. It is very expensive \$5,875 for a powered unit, \$2,200 for a manual unit. Approximately \$8,100.00 for both pieces. We will table this for the time being.

W.Corsiglia reported that we are waiting for the county to issue guidance on the budget election that is to be held on April 20th 2021. There are many unanswered questions. We don't know times or the voting location. The township clerk is working with the county.

# **NEW BUSINESS:**

D.Ricci reported that he has spoken with Elmer Door regarding the installation of safety light beams for 3 front doors on the fire side of the station, the door have been giving us trouble with going up and down. Estimate to install is \$2,775.00.Motion by M.Panco to install 2nd by W.Corsiglia.

Discussion was held on the border trees on the property as to falling over in high winds. We will think about other options to correct, fence etc.

M.Panco reported that we had the car C-29 and the pickup F-1227 serviced at Real Speed garage across the street from the station.

M.Corsiglia reported that the tree chainsaw on F-1223 is bad (It's about 20 years old) no compression. A replacement saw will be about \$600.00 with a sharpener and extra chain. Motion by W.Corsigla to purchase 2nd by R.Ruggeri.

M.Panco advised that he had spoken with our computer man and he advised that we should have a NAS backup for our computer system so we don't lose files. The cost is \$397.00 Motion by M.Panco to purchase 2nd by D.Ricci.
