OLD BUSINESS:

The truck committee reported that they are working on truck options for F-1220's replacement.

M.Corsiglia reported that F-1227 is now back from Ralph's body shop for the repairs, they did not charge us. W.Corsiglia will send them a thank you letter.

M.Corsiglia reported that the cascade compressor is still down, no repairs completed yet. They had to order some parts.

M.Panco still needs to check on why the s/west corner exit light is still not working.

M.Corsiglia is working with Mid- Atlantic to get the grant writer to come to our August meeting. We need to confirm the correct DUNS # for the fire co.

M.Corsiglia reported that F1223, F1221 and F-1222 still need to be serviced this year. The pumps on F-1221 and F-1223 also still need to be serviced, he waiting for call back from Fire & Safety.

D.Ricci will call Capri Construction to see if the repairs to the roof are totally done.

M.Panco stated that the keys in the small key box need to be checked and moved into the new larger box.

D.Ricci reported that he and M.Panco are working on a problem that our website is not on the internet .

Old Business: Con't

M.Corsiglia and D.Ricci reported that sprays have been purchased and the equipment and gear are sprayed after the calls. We are still waiting for the (200) N95 masks to come in.

NEW BUSINESS:

M.Corsiglia advised that the ice machine has been shut down and cleaned out. We need to have it serviced. R.Ruggeri will contact D.Collins for repairs.

M.Corsiglia reported that the refrigerator in the dayroom is leaking, cannot see where it's coming from. D.Ricci will contact and vendor to come and check it out.

M.Corsiglia advised that we have a bad blower motor belt off in the utility room ceiling. D.Ricci will contact Ambient Air for the repairs.

M.Corsiglia advised that the pressure washer hose is blown out, he will call for a new one.

M.Corsiglia explained the Tango/Tango cell phone radio and enables an officer to talk on is cell phone instead of an 800 radio. He has been trying it out now for a few weeks and it seems to be working ok. The fire companies in Buena Boro are using it, Since we are still trying to convert all of our portables to 800 radios this would free up some of the 800 radios that we have to be put in the trucks, since it will be a couple of years until we can purchase all the radios that we need. The cost for 1 year for 10 officers would be approx \$1,200.00 . Motion by D.Ricci to sign up for 1 year for 10 officers. 2nd by R.Ruggeri .
